

**RECORDING INDUSTRY ASSOCIATION OF AMERICA'S  
REQUEST FOR ORAL ARGUMENT RE  
CHARTER COMMUNICATIONS' MOTION TO QUASH SUBPOENA  
AND CHARTER COMMUNICATIONS' MOTION FOR PROTECTIVE ORDER**

1. Pursuant to E.D. Mo. L.R. 78 – 4.02(B), RIAA respectfully requests oral argument concerning Charter Communications' ("Charter") Motion to Quash Subpoena in the foregoing matter. RIAA also requests oral argument concerning Charter's Motion for a Protective Order, to which RIAA will file its opposition shortly.
2. RIAA believes that oral argument will assist the Court because both of the foregoing Motions concern a relatively new statute of great importance to copyright owners, namely the Digital Millennium Copyright Act, 17 U.S.C. § 512 ("DMCA").
3. In addition, given that Charter has raised issues in its Motion for a Protective Order concerning subpoenas that were issued out of another court, RIAA believes that oral argument will ensure that this Court has a full background on the history of RIAA's efforts to

obtain information about the 93 Charter subscribers who are, collectively, unlawfully disseminating more than 100,000 copyrighted works.


