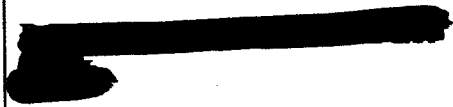


1 The Court having considered the parties' Joint Administrative Motion to
