COMPLAINT

NOW COME LIGATT SECURITY INTERNATIONAL INC., SPOOFEM.COM USA,
INC., and GREGORY D. EVANS ("Plaintiffs"), by and through undersigned counsel, and
hereby file their Complaint against the above-captioned John Doe Defendants and Grey
McKenzie, showing the Court as follows:

PARTIES

1. Plaintiff LIGATT Security International, Inc. is a California corporation that is duly licensed to conduct business in the State of Georgia. LIGATT's principal place of business in Georgia is located in Norcross, Gwinnett County, Georgia.

2. Plaintiff SPOOFEM.COM USA, Inc. is an Oklahoma corporation that is duly licensed to conduct business in the State of Georgia. SPOOFEM's principal place of business in Georgia is located in Norcross, Gwinnett County, Georgia.

3. Plaintiff Gregory D. Evans is a Georgia resident and the Chief Executive Officer of LIGATT Security International, Inc. and SPOOFEM.COM USA, Inc.

4. Upon information and belief, Defendants are "unknown" individuals who reside in various states across the United States. Defendants are also known by certain "aliases" as described in the caption of this Complaint (the "Alias Defendants").

5. Upon information and belief, Defendants John Does 21 through 25 own, administer and/or manage certain website addresses commonly known as www.nationalcybersecurity.com, www.spycopcorporate.com, www.spycop.com, www.exxxterminator.com, and www.softmediapublishing.com, respectively. (the "Website Defendants").

6. Upon information and belief, Defendant Grey McKenzie is a Florida resident who resides at 3402 Trimmingham Lane, Panama City Beach, Florida 32408 ("McKenzie"; together with the Alias Defendants and the Website Defendants, the "Defendants"). McKenzie may be served with process at such address.

JURISDICTION AND VENUE

7. Defendants are subject to the jurisdiction of this Court because they, among other things, committed a tort in Georgia.

8. Venue is proper in this Court because, among other reasons, Defendants committed torts in Gwinnett County, Georgia.

BACKGROUND FACTS

9. Plaintiffs LIGATT Security and SPOOFEM are in the business of providing computer security services and related products and services.

10. Yahoo maintains an Internet site that operates and maintains "message boards" concerning various topics where users can post messages for the public to view on the Internet.

11. One Yahoo message board concerns Technology.

12. On various dates, the Alias Defendants, while using the aliases described in the Caption of this Complaint, published false, misleading, and untrue statements about Plaintiffs on Yahoo's Technology message board.

13. Similarly, on various dates, the Website Defendants and McKenzie published false, misleading, and untrue statements about Plaintiffs on their respective websites.

COUNT I

Defamation

14. Plaintiffs incorporate by reference the allegations set forth in paragraphs 1 through 13, above.

15. Defendants' statements about Plaintiffs are false and untrue, and defamed Plaintiffs.

16. By publishing the statements on the Yahoo Technology message board and the websites, Defendants published defamatory statements to a wide range of persons in the public.

17. Defendants negligently published the false and defamatory statements about Plaintiffs, causing them to suffer damages, including monetary losses, emotional distress, and injury to their reputation.

18. Defendants published the false and defamatory statements with the knowledge that the statements were false, or with reckless disregard as to the falsity of the statements.

19. Defendants' defamatory statements injured the reputation of Plaintiffs.

20. Such damages are in the amount of at least \$5 million.

COUNT II

Commercial Disparagement

21. Plaintiffs incorporate by reference the allegations set forth in paragraphs 1 through 20, above.

22. Defendants' statements about Plaintiffs are false and untrue, and disparaged Plaintiffs' commercial services and products.

23. By publishing the statements on the Yahoo Technology message board and the websites, Defendants published disparaging statements to a wide range of persons in the public.

24. Defendants negligently published the false and disparaging statements concerning Plaintiffs' commercial services and products, causing Plaintiffs' customers to regard Plaintiffs as dishonest, and imputing deceit, dishonesty and reprehensible conduct to Plaintiffs.

25. Defendants published the false and disparaging statements about Plaintiffs causing Plaintiffs to suffer special and general damages, including the monetary loss of important and valuable clients and business, and injury to the reputation of Plaintiffs.

26. Such damages are in the amount of at least \$5 million.

27. Defendants published the false and disparaging statements with the knowledge that the statements were false, or with reckless disregard as to the falsity of the statements.

COUNT III

Tortious Interference With Contractual Relations

28. Plaintiffs incorporate by reference the allegations set forth in paragraphs 1 through 27, above.

29. Defendants intentionally damaged Plaintiffs' relationships with its customers and vendors.

30. In damaging such relationships, Defendants acted improperly and without privilege.

31. Such damage was caused by Defendants purposefully and with malice with the intent to injure Plaintiffs.

32. As a direct and proximate result of such injury, Plaintiffs have suffered damages for which Defendants are liable to Plaintiffs.

33. Such damages are in the amount of at least \$5 million.

COUNT IV

Injunctive Relief

34. Plaintiffs incorporate by reference the allegations set forth in paragraphs 1 through 33, above.

35. This Court has the authority to grant an injunction and other interlocutory extraordinary relief in substantially the manner and under the same rules applicable in equity cases.

36. For the reasons stated above, Defendants should be enjoined from continuing to post and/or publish defamatory and disparaging statements about Plaintiffs.

37. Plaintiffs are entitled to such injunctive relief.

COUNT V

Attorneys' Fees


38. Plaintiffs incorporate by reference the allegations set forth in paragraphs 1 through 37, above.

39. The misfeasance and wrongful conduct of Defendants evidences such bad faith, vexatiousness, stubborn litigiousness, and was carried out with such conscious and reckless disregard of the rights of Plaintiffs that such conduct on the part of Defendants entitles Plaintiffs to recover reasonable costs and expenses, including but not limited to, attorney's fees incurred in connection with this action.

WHEREFORE, Plaintiffs pray that:

1. Process issue and be served upon Defendants;
2. Plaintiffs be awarded compensatory, consequential and punitive damages in amounts to be determined at trial;
3. Plaintiffs be awarded attorneys' fees against Defendants;
4. Costs of this action be taxed against Defendants; and
5. Plaintiffs be granted such other and further relief as this Court shall deem just and proper.
