In response to your most recent questions, section M of CD-044005, Internet Use, was added in July of 2013. The section was drafted with a primary focus on employees, so as to inform them about the internet restrictions for inmates.

The discipline or misconduct report regarding inmate Aldaz was previously provided to you. His discipline appears to be primarily based on his failure to follow directives. I am now providing CD-090100, Inmate Discipline, for your review as well.

The Department is reviewing Mr. Aldaz's misconduct report. The Department is also reviewing its procedures regarding the prohibition against inmates using social media to see if they can be enhanced or improved.

The Department has no other responsive documents or records, and has now fully responded to your IPRA request.
