**JOINT MOTION TO UNSEAL THE GOVERNMENT’S RULE 28(J)
LETTER SUBMITTED ON FEBRUARY 12, 2015**

The parties to the above-captioned appeals jointly move to unseal the government’s Rule 28(j) letter submitted on February 12, 2015 (ECF No. 80 in Case No. 13-16732; ECF No. 89 in Case No. 13-16731; ECF No. 91 in Case No. 13-15957) and this motion. The parties are in agreement that the letter should be unsealed because it contains only public information. Unsealing is proper, reflecting the “general right to inspect and copy public records and documents,

including judicial records and documents.” *Kamakana v. City and County of Honolulu*, 447 F.3d 1172, 1178 (9th Cir. 2006) (citing *Nixon v. Warner Commc’ns, Inc.*, 435 U.S. 589, 597 & n.7 (1978)).
