Here is a synopsis of what I have obtained so far. The caveat is that the airborne missions are not recorded in [redacted] metrics. I also cannot locate any data in Sentinel and [redacted]. Therefore, the data I have is based upon an urgent email request that was sent out to the field [redacted]. There may be additional missions that can be reported in the future, when all the [redacted] respond (the email was sent 06/08/2015). Also, some of the missions might go back as far as [redacted] when [redacted] had tried to start a nascent aerial capability. At that time, CSS gear was sent to [redacted] [redacted] had gear, but they sent it back for lack of interest/usage. The POC for that program, [redacted] reached out specifically to those offices in addition to the [redacted]-wide email I sent. All offices reported back with the same stats as the ones emailed to me. There may also be airborne missions that involved [redacted] that are no longer in the tech program or retired, so I cannot say for certain that the mission numbers are 100% accurate. So far, we have five airborne missions reported.

- 1.) [redacted] has an urgent need for the field to check for a Dell Laptop with Inventory Number [redacted].
[redacted] Most likely, this laptop was sent to the field as a [redacted]. If you have genuinely located it, please contact me with your ransom demands for verifying the laptop's existence (send a picture of the service tag number to me, if you wish to engage in negotiations).
- 2.) Due to a recent misleading story in the AP, Congress and the public are under the assumption that the FBI operates a fleet of aircraft with the CSS capability. My understanding is that the technique was initially deployed back in [redacted] but was rarely, if ever, used. I am reviewing [redacted] for any aerial missions, but that database may not be accurate. So from [redacted] onward, if you recall a CSS aerial mission occurring in your current or prior Field Office, please let me know. We have been asked for specific mission numbers.
