Dear Commander Ng:

The Union Square Alliance has considered the request contained in your email correspondence to obtain temporary access to the Union Square Alliance's camera system during the planned Protests and time period requested based on the following:

Justification of Commanding Officer's decision:

Live monitoring request based on information received from Major City Chiefs and Memphis Police Department related to potential civil unrest upon release of Body Cam Footage from Memphis PD's In Custody Death incident. Similar historical events have prompted large scale riots and looting across the Nation. There are demonstrations already planned within the Union Square footprint (during high commute hours) and the use of live monitoring will allow SFPD to prevent potential felony vandalism and major looting and crimes that are generally associated with civil unrest as seen in previous events. This will allow SFPD situational awareness to re-deploy the necessary resources.

The Union Square Alliance approves your request to view cameras in the interest of protecting the safety of the members of the public, and the justification above.
