
~~PROPOSED~~ ORDER VACATING

5 IT IS HEREBY ORDERED THAT:

- 6 1. The Court’s Order of March 21, 2014 (ECF No. 103), concerning the preservation of
7 evidence that may be relevant to this action, is hereby VACATED.
8 2. The Government is hereby relieved of any further preservation obligation in this action
9 and, for purposes of this action, is free to destroy the “BR metadata” described in the
10 parties’ Joint Stipulation.
