1 I, J. Ashlee Albies, hereby declare as follows:

2 1. I make this declaration of my own personal knowledge and could testify thereto if  
3 called as a witness.

4 2. I graduated from Lewis and Clark Law School in 2005 and was admitted to the  
5 Oregon bar that same year. During law school, I served as a law clerk for the Lewis and Clark Legal  
6 Clinic in Portland, OR, providing legal services to low income residents of Portland. In addition,  
7 I served as a law clerk for the Center for Constitutional Rights in New York, where I worked on  
8 international human rights cases, as well as cases involving government misconduct. From  
9 November 2005 through February of 2008, I was in solo practice, focusing on plaintiff-side litigation  
10 in the areas of family, employment, and civil rights law in Portland, OR. From February 2008  
11 through the present, I have been a litigation associate at Steenson, Schumann, Tewksbury, Creighton  
12 & Rose, PC in Portland, OR where I continue to litigate plaintiff-side employment and civil rights  
13 cases. I have litigated cases in both federal and state court, at both the trial and appellate levels.

14 3. I also serve as counsel representing the Center for Constitutional Rights in its  
15 challenge to the same NSA wiretapping program . That case is currently pending in the Northern  
16 District of California, Case No. 3:07-cv-01115-VRW. I have presented at several Continuing Legal  
17 Education seminars on Civil Rights, specifically on the topics of civil rights and the First  
18 Amendment and on changes to Federal Law in the area of Civil Rights. In addition, I serve on the  
19 Oregon State Bar Civil Rights Section Executive Committee, and serve as Chair of the Portland  
20 Chapter of the National Lawyers Guild.

21 4. Almost all of my practice involves representation of clients in cases on a contingent  
22 basis (primarily involving constitutional and civil rights issues).

23 5. I joined the litigation team in this case prior to the complaint being filed on February  
24 28, 2006. I provided preliminary research and analysis on key issues in this case prior to filing, and  
25 continued to provide research and analysis throughout this litigation, including the defendants'  
26 interlocutory appeal to the Ninth Circuit and the case's MDL transfer from Oregon to the San  
27 Francisco Bay Area.

28 6. I maintained time records in this case in the same manner as I maintain time records

1 for all of my other direct billing and contingent cases. Throughout the course of my work, I  
2 contemporaneously record the time spent on specific tasks for my work that day. However, over the  
3 course of this litigation, I have changed offices and used two different billing programs.

4 7. Pursuant to Civil Local Rule 54-5(b)(2), I provide the following statement of the  
5 services I have rendered in this case and summary of the time I have spent providing those services.  
6 At the Court's request, and pursuant to Civil Local Rule 54-5(b)(2), I am prepared to produce my  
7 contemporary time records or an abstract thereof for *in camera* inspection by the Court, if the Court

 8 preparation and travel to hearing in San Francisco, review of Inspector General’s report on NSA  
 9 program, review/edit plaintiff’s motion to strike, review and analysis of new cases on state secrets  
 10 privilege (6/11/09 - 9/23/09): 21.5 hours.

11 • Analysis, legal research, consultations with co-counsel re: March 2010 District Court  
 12 opinion and post-decision strategy, punitive damages, review/edit of punitive damages memo  
 13 (3/31/10 - 5/5/10): 11.9 hours.

14 • Research into cost recovery, preparation of fee declaration (6/25/10 - (6/29/09)): 9.5  
 15 hours.

16 8. Based on the foregoing, my total hours in this case are 467.2. Using the Laffey matrix  
 17 hourly rate of \$294 (for attorneys with 4 to 7 years of experience), I request an award of reasonable  
 18 attorney fees in the amount of \$137,356.80.

19 9. I also incurred certain litigation costs in this matter. Those costs include travel costs  
 20 to San Francisco for court hearings. I believe those costs are properly reimbursable insofar as this  
 21 case was transferred from the District of Oregon, where it was initially properly filed, to the Northern  
 22 District as a result of defendants’ motion to the Joint Panel on Multidistrict Litigation. Further, on  
 23 information and belief, the standard practice in the Northern District of California is for attorneys  
 24 to bill their clients for such travel expenses and messenger charges separate from their hourly rates.

25 The expenses I am seeking reimbursement for are as follows:
