Appendix 3 - Block Billing by Counsel

*Block Billing:* Defendants applied the following criteria to determine “serial or “block” billing entries. Entries that describe hours spent on more than one identifiable subject area, discrete work product, or distinct type of activity (including reference to “related tasks”) are counted as block billed. In applying this rule, entries indicating solely that counsel reviewed, analyzed, and prepared a filing on one particular subject matter (e.g. opposition to a motion to dismiss) were not counted as serial/block billed. Entries indicating that counsel prepared for and attended a hearing were treated as serial/block billed because they do not distinguish the time spent on each activity. In light of the numerous references to “consultations” with co-counsel in the declarations, Defendants have attempted to calculate an amount of hours for such “consultations” and have set forth a separate reduction for those hours. *See* Appendix 4. Thus, where a consultation with co-counsel was listed with what Defendants judged to be a single subject activity, the entry was not treated as block billed.

Using the foregoing criteria, the following lists the “bullet point” entries in the respective counsel’s declaration that are treated as serial/block billed. These block billed hours are totaled and subjected to a 30% reduction.

Note: Page references in the chart are to the page numbers indicated in the ECF generated header at the **top** of the declaration cited.
