Dear Counsel

Attached is a proposed schedule for further MDL proceedings in the Carrier and Government cases only. The schedule does not include dates for any other activities that may need to be added. For example, the Government is separately discussing a schedule with the State PUC Defendants for briefing those cases. In addition, nothing is scheduled in Hepting (and the non-Hepting AT&T cases) unless and until the court rules on discovery and permits further proceedings. Also, the Court has not yet ruled on whether Al-Haramain will proceed. Thus, this schedule is based on what we believe will proceed at this time and is subject to change to accomodate additional events.
