Pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii), plaintiff Electronic Frontier Foundation (“EFF”) and defendant Office of the Director of National Intelligence (“ODNI”) stipulate that all claims in the above-captioned case are dismissed with prejudice in their entirety.

To facilitate the parties’ negotiation of attorney’s fees, EFF and ODNI stipulate to a waiver

1 of the 14-day time limit to serve and file a motion for an award of such fees under Local Rule 54-6.  
2  
3 If EFF and ODNI are unable to reach a mutually acceptable agreement on this issue, they will brief  
4 the matter according to the following schedule:

- 5 • EFF will move for attorney’s fees no later than April 11, 2008.
- 6 • ODNI will oppose EFF’s motion for attorney’s fees no later than April 25, 2008.
- 7 • EFF will reply to ODNI’s opposition no later than May 2, 2008.
- 8 • The Court will hear the motion for attorney’s fees on May 16, 2008.
