This is a final response to your Freedom of Information Act (FOIA) request dated February 13, 2009, and received in this Office on February 17, 2009, in which you requested reports submitted to the Attorney General from the Intelligence Oversight Board from January 1, 2007 to present. This response is made on behalf of the Office of the Attorney General.

By letter dated November 5, 2009, you were advised that we had completed our search in the Office of the Attorney General and were reviewing the documents located. Please be advised that this included a search of the electronic database of the Departmental Executive Secretariat, which is the official records repository for the Office of the Attorney General. Our review is now complete and we have determined that six unclassified documents and five classified documents are responsive to your request.

With regard to the unclassified documents, I have determined that one document is appropriate for release without excision and a copy is enclosed. Of the remaining unclassified documents, one was referred to the Department of Energy and four were referred to the Office of the Director of National Intelligence for processing and direct response to you. 


