**DECLARATION OF ART SCHREIBER IN
SUPPORT OF LANDMARK EDUCATION,
LLC'S SUBPOENA**

14 I, Art Schreiber, declare as follows:

16 1. I am an attorney duly licensed to practice law in California, and am general
17 counsel for Landmark Education, LLC ("Landmark Education"). This declaration is made in
18 support of Landmark Education's request for issuance of a 17 U.S.C. section 512(h) subpoena
19 from the United District Court, Northern District of California.

21 2. On September 24, 2006, a series of seven videos labeled "Introduction" and Inside
22 the Landmark Forum" (1 through 6 of 6) was posted by "Asatgiaire" on the Web. The videos
23 include portions of Landmark Education's copyrighted and proprietary course entitled "The
24 Landmark Forum." Landmark Education has never authorized – and, in fact, strictly prohibits –
25 the videotaping and public dissemination of the contents of its copyrighted course.

26 3. The subpoena Landmark Education seeks will be used only to obtain the identity
27 of the alleged infringer, and the information will be used only for the purposes of protecting
28 Landmark Education's copyright.


