
2. Any and all information related to the internet blog, "daTruthSquad," located at <http://www.datruthsquad.blogspot.com>, for the time period beginning August 7, 2007 through the present, including, but not limited to, the account holder's name, mailing address, email address, telephone number, URL, IP address, browser type and language, any and all account information, including account settings, profile information and any changes or updates to the account holder's information, copies of the weblog posts and comments, including drafts, any and all emails received by Google from the account holder, any and all emails sent on Google's server by the account holder, the source of the information being posted on the blog, and any other information associated with this account.

Failure to appear according to the command of this Subpoena will subject you to a penalty, damages in a Civil Suit and punishment for contempt of Court.
