Inc. shall immediately but no later than December 28, 2009 provide to Plaintiff any and all documents relating to and containing information as to the identity of the IP address identified as 76.112.208.127 in utilizing the e-mail address of "mmlere2006@yahoo.com" including but not limited to, account application forms and billing address and name information; and it is further

ORDERED, that Facebook shall immediately but no later than December 28, 2009 provide to Plaintiff any and all documents relating to and containing information as to the identity of the individual or individuals utilizing the username "Tunnel Rat," including but not limited to, account application forms and billing address and name information; and it is further

ORDERED, that www.endh1b.com is temporarily and preliminarily enjoined and shall immediately remove any and all postings and references to Sarvesh Kumar Dharayan and Apex Technology Group, Inc. its officers, shareholders, employees, representatives and legal counsel until further order of this Court; and it is further

ORDERED, that www.itgrunt.com is temporarily and preliminary enjoined and shall immediately remove any and all postings and references to Sarvesh Kumar Dharayan and Apex Technology Group, Inc. its officers, shareholders, employees, representatives and legal counsel until further order of this Court; and it is further

ORDERED, that www.guestworkerfraud.com is temporarily and preliminarily enjoined and shall immediately remove any and all postings and references to Sarvesh Kumar Dharayan and Apex Technology Group, Inc. its officers, shareholders, employees, representatives and legal counsel at any time until further order of this Court; and it is further

ORDERED, that discountASP.NET is temporarily and preliminarily enjoined from hosting the website www.endh1b.com and shall immediately shut down and disable the website www.endh1b.com until further order of this Court; and it is further

ORDERED, that GoDaddy.com, Inc. is temporarily and preliminarily enjoined from hosting the website www.endh1b.com and shall immediately shut down and disable the website www.endh1b.com until further order of this Court; and it is further

ORDERED that Domains by Proxy, Inc. is temporarily and preliminarily enjoined from hosting the website www.itgrunt.com and shall immediately shut down and disable the website www.itgrunt.com until further order of this Court; and it is further

ORDERED that Samir Patel, c/o Network Solutions is temporarily and preliminarily enjoined from hosting the website www.guestworkerfraud.com and shall immediately shut down and disable the website www.guestworkerfraud.com until further order of this Court; and it is further

ORDERED that the defendant(s) posting and corresponding under the usernames admin@endh1b.com, H1BScam and mmillere2006@yahoo.com may move to modify or dissolve the temporary restraints contained herein on not less than three (3) days notice; and it is further

ORDERED that Plaintiff shall serve this Order by e-mail upon admin@endh1b.com on or before December 23, 2009 at the aforesaid e-mail address; and it is further

ORDERED that Plaintiff shall serve this Order by e-mail upon mmillere2006@yahoo.com on or before December 23, 2009 at the aforesaid e-mail address; and it is further


